### Minutes of the meeting in PIL 176/2012 on 04/07/2017

Meeting in PIL 176/2012 was conducted under the chairmanship of Divisional Commissioner, Nashik Division.

The points discussed in the meeting are as follows :

- (1) Nashik Municipal Corporation : Commissioner NMC shall give in brief details regarding ,
  - 1) A separate detail Audit of sewage collection and its disposal.
  - 2) The areas like slums, newly developed residential areas, farm houses etc. Should be identified and decided, this should be included in the Sewage draft.
  - 3) The expenditure needed for the above sewage collection, treatment and disposal should be framed. The up gradation of the STPs, cost of inter sewer lines etc. should also be included in the total expenditure required. ( the report should be submitted within a week)
- (2) Chief Executive Officer, Zilla Parishad Nashik :

According to your report dt. 5/6/2017 you have mentioned that six villages ie. Chandori & Saykhada from Niphad tahsil, Odha, Eklahare, Lakhalgaon & Sansari the sewage let out should be diverted and the pollution of Godavari should be stopped. The expenditure for this should be submitted within a week.
- (3) Nashik Municipal Corporation & Maharashtra Pollution Control board :

Officers of NMC & MPCB to visit nallas coming through the Artillery centre and joining the tributaries of Godavari river.
- (4) Executive Engineer Maharashtra Industrial Development Corporation :

MIDC, Nashik & NMC should prepare a detail DPR for the collection & transportation of the sewage generated in MIDC area. (The report should be submitted within a week.)
- (5) Maharashtra Pollution Control Board : They are to submit a detail report regarding the working of STPs of NMC. Periodic inspections according to their specific Acts. Secondly they should also mention what strenuous effort they have taken to prevent pollution of Godavari river( written statement to be given within a week).

- (6) Land Acquisition Officer, Nashik : The land acquisition proceeding of Pimpalgaon Khamb should to be completed as early as possible.
- (7) Joint Director Town Planning : The Hon. High Court has directed to the State Government to take appropriate decision on the draft development plan of Nashik Municipal Corporation considering the orders of the Hon. High Court and the recommendations of National Environmental Engineering Research Institute .
- (8) National Environmental Engineering Research Institute : NEERI & NMC should jointly study the problem of foam generation at the discharge of the STPs and also the efficient working of the STPs as discussed and they shall submit report of the progress to this office.
- (9) Collector Nashik : The illegal sand mining along the banks of River Godavari & its tributaries as reported in the reports of NEERI should be inspected & report should be submitted within a week.
- (10) Hon. High Court's order dt. 30/03/2017: regarding the construction in river bed & Blue line the status should be submitted to the Committee.
