Minutes of the meeting held on 31ST March 2018
in Hon. High Court's PIL 176/2012

As per the direction given by Hon. High Court in PIL 176/2012, the committee under the chairmanship of Divisional Commissioner Nashik is constituted to review the progress made by various agencies in tackling issues related to pollution of Godavari River.

The main point of discussion in the meeting was issue of construction of retaining wall on the banks of Nasardi River. Hon. High Court had given instructions in it's order dt.6/7/2017 that Commissioner, Nashik Municipal Corporation should make applications to the Divisional Commissioner, Nashik and the decision shall be taken by the Committee regarding construction of retaining wall.

A meeting was taken on 1ST November, 2017 & NEERI, Nashik Municipal corporation & Water resources Department were given instructions & told to make compliance on several points.

Divisional Commissioner gave the following instructions :

Nashik Municipal corporation : a) In case of the retaining wall (Cement Concrete wall near Wadala bridge) on both sides of Nasardi river, Nashik Municipal corporation has constructed 200 mtrs wall & 100 mtrs is remaining. Committe has no objection if NMC will construct the remaining 100-125 mtrs in gabin type wall as per the instructions of NEERI.

b) In case of the second retaining wall between at bhabha Nagar (Raje Shivaji Margdarshan Kendra & Sambhaji Chawk) on the bank of Nasardi river, which is a cabian wall, Nashik Municipal corporation has received approval for the design which NMC had sent from NEERI, they can complete the gabin wall.

c) Sewage audit has to be completed within 15 days & submit it to the committee. NMC should provide names of those societies to MPCB, so that they can take severe action against these societies. They should also submit a detail report regarding the various Nalas which join Godavari River (their physical structures, where the gutters meet them before they meet Godavari River & what type of various treatment which should be given to avoid the pollution of Godavari River.

d) To prepare a DPR regarding the drainage line in MIDC area as discussed.

Maharashtra Industrial Development Corporation :

a) MIDC should complete the construction CETP as early as possible as per the direction of Hon. High Court.

b) MIDC should conduct Monthly meetings of various industrial associations & should ensure that the affluent generated by the industries is treated before the disposal.

Land Acquisition Officer, Nashik : To complete the land acquisition proceeding of Pimpalgaon Khamb as early as possible according to Hon. High Court's directions.

Police Department : Commissioner of Police, Nashik should write a reminder letter to Hon. Director General Police, Maharashtra State for the sanction of police personal as per the directions of Hon. High Court.

Maharashtra Pollution Control Board : To take samples at various places of Godavari River & also to make regular inspections according to their specific Acts.
