The service providers to give plans in Detail in following pattern

- 1) Bandwidth – Min 100/50 Mbps 1:1 dedicated lease line -

Band width	100 Mbps	50 Mbps
Annual Tariff	Rs.	Rs.

- 2) Annual Tariff for 1:1 dedicated lease line in INR including GST.
- 3) The Internate connectivity leased line should have fully dedicated (1:1) unshared & High Quality symmetric bandwidth without any compression factor through Optical fiber.
- 4) Type of connection cable. – OFC
- 5) Bidder should have its own fiber backbone with auto switch over.
- 6) Required hardware to be supplied by service provider if necessary.
- 7) Bidder should have National class A ISP, Provide certificate for the same.
- 8) ISP must have DOT License to operate at International Gateways (Attach a copy of License document).
- 9) Backbone bandwidth should be more than 30 Gbps and backbone should be in ring.
- 10) Operator should have centralized network operating centre.
- 11) Service Support-The bidder should provide support for trouble shooting on 24 X 7 X 365 basis so that the maximum availability of the Internet connectivity is ensured.
- 12) Operator should have toll free fault booking number.
- 13) Operator should not be cable operator.
- 14) The ISP must be a member of NIXI (National Internet Exchange of India) (Attach a copy of membership document) and must have peering with National Internet Exchange of India at minimum 3 locations.
