B)	<u>FINANCIAL BID</u> :-

NMC will not bear any expenses other than the cost quoted for the work. The agreement will have to be carried out on the stamp paper. C)	CONDITION FOR PAYMENT OF ADDITIONAL PERFORMANCE SECURITY DEPOSIT :-

6)	During the opening of Envelope No,1, if the tenderer founds not upto the mark of technical qualifications, then the demand draft / FDR/ Bank guarantee of tenderer who does not fulfill the technical criteria will be returned back within seven days.
7)	Submission of false/misleading documents/demand drafts / FDR/ Bank guarantee of any will result in forfeiting of EMD & liable for further action against such tenderer.
