#### CONDITION FOR PAYMENT OF ADDITIONAL PERFORMANCE SECURITY DEPOSIT

In case of contractor offer is less than 10% of updated estimate cost.

- 1) The contractor shall require to furnish the performance security deposit in the form of demand draft/recoverable Bank Guarantee of Nationalised Bank/ Scheduled Bank containing Envelope No. 2 & also the scan copy of demand draft & Bank gurantee submit with E-tender (e.g. 1 to 10% below -1% cost)
- 2) If offer quoted is lesser than 10% then the tenderer shall require to submit the D.D./ Bank guarantee in Envelop No.2 including the above cost as per Sr. No. 1 (e.g.14% below rate upto 10% i.e.1% + (14%-10%) 4%=5%)
- 3) The amount of performance security deposit shall be worked out as per following formula, if lesser than 10% below = Rs {%rate quoted by contractor-10} x cost put to tender + 1% of cost put to tender.

If the lowest bidder offer is more than 10% below the estimated cost of tender, tender calling authority should be cal for the written explanation from this bidder with respect to the planning of execution of work as per rate quoted by him. Tender calling authority should as sure himself about the feasibility of planning submitted by the bidder with respect to the quoted rates.

If the lowest offer of the bidder is more than 10 % of the estimated cost of tender, then said bidder should be submit the D.D. in Envelope No.2 of nationalized bank or schedule bank equivalent to the different below percentages quoted by him above the 10% below the tender cost in addition to the cost in (2) above. Submission/Return of Demand Draft/ Bank guarantee To be adopted as follow

- g) During the opening of Envelope NO.1, if the tenderer founds not upto the mark of technical qualifications, then the demand draft / Bank guarantee of tenderer who does not fulfill the technical criteria will be teturned back wihin seven days.
- h) After evaluation of technical bid, the demand drafts/ Bank guarantee of all the tenderes except the lowest two tenderes will be teturned back within seven days.
- i) The demand draft / Bank guarantee of the second lowest tenderer will be returned within 3 days after the issue of work order to the lowest bidder.
- j) Submission of false/misleading documents/demand drafts / Bank guarantee of any tender will result in forfeiting of EMD & liable for further action against such tenderer.
- k) The Executive Engineer shall issue the work order to the lowest bidder only after encashment of demand draft / the Bank guarantee of Performance Security deposit Bankg guarantee / Demand Draft must be valid for the period of DLP plus one month.
- 1) The performance security of the successful tenderer will be returned after a period of three months from the, satisfactory completion of the work as per tender specifications.
