- 2. Quotations from reputed agencies having license for handling pest control chemical and having experience in handling pest and rodent control operations are invited.
- 3. Pest and Rodent Control treatment should be carried out in the areas of the respective units as directed by the concerned Medical Superintendent/Medical Officer.
- 4. The agency will ensure that while the operations is carried out in food preparation and storage areas, no food items are contaminated by the chemicals used for pest control. Adequate preventive measures should be taken to avoid food contamination.
- 5. The Pest and Rodent Control treatment should be carried out **Min. 2 times with 6 months gap** and sufficient staff should be present in the units throughout.
- 6. Only competent staff having sober habits, good character and conduct shall be engaged.
- 7. The agency will use their own equipments and chemicals. The agency should only use CIB registered household chemical which are odorless and which are not harmful to people.
- 8. Contractor shall produce Contract Labour License of there existing contracts under the regulation of contract labour act 1970.
- 9. Contractor to have produce license of using Pest Control Chemicals from Govt. Agriculture Dept. of any State Govt./Central Govt./Union Territory or equivalent Govt.Dept..
- 10. G.S.T. Registration Certificate.
- 11. The quoted rate should be net and should include charges for equipments, chemicals all taxes and other levies.
- 12. As per statutory norms applicable deduction will be deducted from bills & then payment will be done through PFMS (Online).
- 13. Photo Copy of Pan Card of Quotationer.
- 14. Each quotation should be accompanied by certificates from competent authorities showing the past experience of the quotationer in successful completion of similar agencies.
