A) BRIEF SCOPE OF WORK:-

- i)** The Desktop Computers, Laser Printer (Brother/H.P / Canon Only), Printer cum Scanner, Laptop, UPS, Head Phone with Microphone and USB Camera and Misc. Hardware as specified and subject to relevant specifications mentioned in the quotation shall be supplied by the successful vendor as directed by Medical Officer Health of the make and specification as mentioned in the quotation.
- ii)** The agency is required to install the hardware, software and Misc. hardware at the specific locations as directed by Medical Officer of Health, Nashik Municipal Corporation after delivery as above.

1. Quality Assurance Program/Sample Tests

- a) The Medical Officer Health if necessary will instruct the Agency to carry out Third party testing of all the materials such as Desktop, Printers, UPS, Batteries, software, etc to ensure that they are conforming to the relevant Standards and quotation specifications. OR The agency should make arrangement for the Third party testing of at least 5% of Desktop, Printer, UPS, Batteries, software supplied from Government Polytechnic College, Nashik. The Medical Officer Health reserves the right to reject all or some of the material which does not conform to the relevant standards or specifications. The Cost of Third Party testing will be borne by the Agency.
- b) All costs of such sampling, testing and reporting of test results will be borne by the Agency, and the Agency shall include sufficient provisions in his quotation rates to allow for independent sampling and laboratory testing under the direction of the Medical Officer Health. The Agency shall furnish certified copies of all test reports duly signed to the Medical Officer Health within 3 days of completion of the specified tests.
- c) The Medical Officer Health desires to carry out additional certain quality control test as per the guidelines of requisite specifications and code through a third party quality control department of Central Government / State Government / Educational Institute / Private Institute. The Agency should carry out such test and the cost shall be borne by the Agency.

The Agency shall be responsible for installation of the hardware equipment and software ordered, at site and location suggested by Medical Officer Health and also for making them fully operational within 10 days of receiving the hardware / software. Appropriate insurance to cover the equipment for the transit period and till the time of installation at the site is to be taken by the Agency.

1. Guarantee:

The Agency should guarantee that all the hardware & software systems delivered to the Nashik Municipal Corporation are brand new and must have a manufacture's guarantee of at least one year from the completion of the contract with the Nashik Municipal Corporation.

In case of software the Agency should guarantee that the software supplied to the Nashik Municipal Corporation is licensed and legally obtained. The original licenses should be hand over to Nashik Municipal Corporation at the time of supply.

All hardware and software must be supplied with their original and complete printed documentation

2. Cost:

The price for supply, installation, commissioning including on site comprehensive warranty for a period of FIVE year from the date of installation and commissioning of equipment's by the Agency. The warranty shall be inclusive of spares and if any part is found defective the Agency must replace the part free of cost immediately.

3. Factory Inspection and burn – in – tests:

In all cases the Agency shall provide an inspection report / certificate (along with serial numbers of the equipment is as per the purchase order and it conforms to all specification contained in the contract.

On arrival of the equipment at destination the Nashik Municipal Corporation, its representative shall have the right to inspect and / or test the equipment to confirm their conformity to the contract. If the equipment or its performance is not as per specified conditions, the Agency shall take immediate steps to remedy the deficiency to the satisfaction of the Nashik Municipal Corporation's representative.

4. Packing:

The Agency shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination as indicated in the contract. The packing shall be all-weather proof and shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate the remoteness of the goods final destination and the absence of heavy handling facilities at all points in transit.

The packing, marking and documentation within and outside the packages shall comply strictly with such special requirements as shall be provided for in the contract and in any subsequent instructions ordered by the Nashik Municipal Corporation.

5. Deferred Delivery and Fixed Price:

The Nashik Municipal Corporation will have the right to ask for a delayed delivery of part of the consignment ordered. The Agency must be willing to offer the equipment at the same fixed price in the event of such a delay.

6. Delivery Documents:

Within 24 hours of shipment, the Agency shall notify the Nashik Municipal Corporation and the insurance company by cable/telex/fax the full details of the shipment including contract no. receipt no., Date, description of goods, quantity, Nashik Municipal Corporation , etc. the Agency shall mail the following documents to the Nashik Municipal Corporation , with a copy to the insurance company.

- a) 4 copies of the Agency invoice showing goods description, quantity, unit price, total amount
- b) Inspection report
- c) Manufacture's / The Agency 's guarantee certificate
- d) Certificate of origin and

One Identical set consisting of copies of the above documents will be sent through courier by the Agency to the Nashik Municipal Corporation.

7. Integration of Hardware, Software and Peripherals

The Agency must integrate the hardware, software and peripherals supplied by him to make them fully integrated and functional. However, in case of problems with machines, it will be the Agency's responsibility to locate the exact nature of the problem and rectify the same except for the problems in the application software installed on the machine, if any. Under no circumstances will a problem be blamed on the application software without sufficient cause and justification.

The Agency must also take required steps to successfully install all the software components supplied by the Agency on the Hardware. Moreover, any relevant patches which need be applied to the system software to make the software up-to-date, in connection with a specific hardware, must be identified and installed in the hardware from time to time during the warranty period.

The Agency should note that all the equipment and peripherals should be supplied with the relevant interface cables. Also all the equipment must be provided with India Standard, 3-pin power plugs (5 amp/15 amps, as required)

8. Software Drivers and Manuals:

All equipment will have to be supplied with all the software drivers and detailed operational and maintenance manuals for each of the items and important components there in such as Display Monitor, Display controller, Ethernet interface, CD-ROM etc for a particular operating system as applicable, free of cost.

9. Acceptance Tests:

Acceptance test will be conducted by the Agency at the destination sites, either itself or through any of the TSPs from time to time, in the presence of Medical Officer Health, Nashik Municipal Corporation and / or its nominated agency. The tests will involve installation and commissioning and trouble free operation of the complete system for ten consecutive days apart from physical verification and testing. There should not be any additional charges payable by the Nashik Municipal Corporation for carrying out this acceptance test. The Nashik Municipal Corporation will take over the system on successful completion of above test.

10. Completeness of Contract:

The contract will be deemed as incomplete if any component of the hardware, software, network devices, etc or any documentation /media relating thereto is not delivered or is delivered but not installed and / or not operational or not acceptable to the Nashik Municipal Corporation after acceptance testing/examination.

In such an event, the supply and installation will be termed as incomplete and it will not be accepted and the warranty period will not commence. The equipment will be accepted after complete commissioning and satisfactory functioning of equipment for a minimum period of 10 days. The Warranty period will commence only on acceptance (based on acceptance test) of equipment by the Nashik Municipal Corporation.
