QUOTATION NOTICE FOR PEST CONTROL & RODENT SERVICE

Competitive quotations are invited from experienced and reputed Pest Control Agencies for carrying out one time pest and rodent control operations at our 27 uphc (urban primary health centers) and 2 urban community health centres in Nashik Municipal corporations Nashik.

TERMS AND CONDITIONS:

1. Quotations from reputed agencies having license for handling pest control chemical and having experience in handling pest and rodent control operations are invited.
2. Pest and Rodent Control treatment should be carried out the areas of the respective units as directed by the concerned Medical Superintendent/Medical Officer
3. The agency will ensure that while the operation is carried out in food preparation and storage areas, no food items are contaminated by the chemicals used for pest control. Adequate Preventive measures should be taken to avoid food contamination .
4. The pest and Rodent Control treatment should be carried out one time at 27 uphc & 2 uchc at Nashik municipal corporation, Nashik.
5. Only competent staff having sober habits, good character and conduct shall be engaged.
6. The agency will use their own equipments and chemicals. The agency should only use CIB registered household chemical which are odourless and which are not harmful to people.
7. The quoted rate should be net and should include charges for equipments, chemicals all taxes and other levies.
8. As per statutory norms applicable deduction will be deducted from bills and then payment will be done through PFMS (Online)
9. Each quotation should be accompanied by certificates from competent authorities showing the past experience of the quotationer in successful completion of similar agencies.
10. Commissioner, Nashik Municipal Corporation reserves the right to accept or reject any quotations without any reason there of.
11. The corporations reserves the right to refuse to issue the quotation documents to any person or any firm without assigning reason for it.
12. The quotation should be free from errors and corrections.
13. The quotation rates should be inclusive of all taxes, and all other incidental charges if any. The rates should be given both in figures and words. Alternative proposals/rates are liable to be rejected.
14. The corporation has the right to let other agencies In connection with this contract at any time, if found necessary. In case the quotationer refuses to accept the award or refuses to comply with any of the terms & conditions for the award of contract.
15. Contract under the regulation of labour act 1970
16. Contractor have to produce licence of using pest control contract from gvt agriculture dpt of govt/central gvt. union territory or equivalent.
17. The quotation rates should be inclusive of all taxes, and all other incidental charges if any. The rates should be given both in figures and words, Alternative proposals/rates are liable to be rejected.
18. The corporation has the right to let other agencies in connection with this contract at any time, if found necessary, In case the quotationer refuses to accept the award or refuses to comply with any of the terms & conditions for the award of contract.
19. If the contractor fails to arrange the pest control service as per agreed terms and conditions, he has to pay the corporation the cost of damage and loss occurred due from his part.
20. The successful quotationer shall complete all necessary formalities as per rules.
21. The corporation has the power to terminate the contract at any time if found unsuccessful, and to award the contract to another agency, which cannot be questioned anywhere. The corporation reserves the right to negotiate reduction in the rates or to reject any or all quotations without assigning any reasons.
22. The successful quotationer must give an undertaking that the service will be provided as per Nashik Municipal Corporation- Public Health Department's requirement and as per the scope of the quotations.

23. The quotation should be submitted only in the prescribed form issued from the office of the Medical Officer of Health, NUHM Cell 3rd floor, Rajiv Gandhi Bhawan, Sharanpur Road, Nashik.

 - i. All varieties of pests viz., flies, cockroaches, ants, bugs, bottles, moths, spiders, silverfish and Lizards etc.
 - ii. All varieties of rodents viz ,rats, mice etc.
 - iii. All varieties of termites.
2. The disinfection and pest control services in the Hospital/Urban primary Health Center shall cover the entire premises, inside and outside viz., within the boundaries of the office, rooms, bath rooms, toilets, gardens, manholes, open drainage and all other areas etc.
3. The treat shall be according to :-
 - i. Accepted international standards and stipulations.
 - ii. Standards and application recommended by reputed manufactures, scientific authorities, Institution etc.
4. Pest Control experience in PHC/Hospital is mandatory Submit accordingly .

GUARANTEE

The quotationer shall guarantee in writing that the disinfection and pest control treatment(s) Services as follows:

- a) Will not have any deleterious or injurious effect on the articles, plants etc.
- b) Will not have any injurious effect on the health of human beings.

- d) Shall further guard against reappearances or reinfection of all pests, rodents, termites etc. dealt above over a definite and acceptable period of time.

5. Rates/Mode of Payment.

The rate is inclusive of all taxes, octopi, cartage and labour charges etc. and no request for enhancement of rates will be entertained later. The rates are firm for the period of contract.

6. Duration of treatment:

One time pest control service at 27 uphc & 2 uhc..

8. Termination of Contract:
